

TERMS AND CONDITIONS



Please read these terms and conditions carefully before registering in the TRICATIONS. By participating in the event, you agree to be bound by these terms and conditions.

1. Registration:

Participants must register for the event through the official registration process.

All registration details provided by participants must be accurate and complete.

Only participants who have completed the registration process and paid the TRICATION fee will be considered.

2. Eligibility:

Participants must be in good health, physically fit and medically able to complete the entirety of the event without jeopardising their health or life and consent to receive medical treatment that may be advisable in the event of illness or injuries suffered by the participant during this event. The participant declares that they have practiced sufficiently and that they are physically well. The participant understands that event staff are authorised to remove athletes from the event if noticing threatening indications of potential damage to their health.

Athletes declare and guarantee that they are at least 18 years of age and have full authority to enter into this agreement.

3. Assumption of Risk:

Participation in sports events involves inherent risks and dangers. By registering for this event, the athlete accepts participation in the event and the organiser's exclusion of liability of any damage, injury or death. The athlete will not enforce a claim either upon the organiser or upon the supporting companies and their agents because of damage, injury, or death that could arise by participating.

Participants are responsible for their own safety during the event and should take appropriate precautions.

4. Event Modifications or Cancellations:

The event organiser reserves the right to modify or cancel the event due to unforeseen circumstances, including but not limited to adverse weather conditions, natural disasters, or any other event beyond its control.

In the event of cancellation, participants may be eligible for a refund of the booking fee according to the event organiser's refund policy.

6. Liability:

The event organiser, its affiliates, sponsors, and partners shall not be held liable for any injury, loss, or damage to participants' property or person, arising from or in connection with the event.

Participants are encouraged to obtain their own insurance to cover any unforeseen circumstances or incidents that may occur during the event.

7. Media Release:

Participants consent to the use of their image, and likeness in any photographs, videos, or promotional materials related to the event for marketing and publicity purposes.

The athlete accepts and agrees to the recording and/or broadcasting of this event and hereby grant the organiser all rights (including, without limitation, copyright) and consents worldwide in perpetuity, in any and all media, without payment, liability or acknowledgement to the athlete to use and publish the athletes name, image, likeness or other information for promotion of this event and/or any other purposes of the organiser (including sharing with third parties for any lawful purpose). The athlete hereby confirms that they do not object to any usage of the said information in any way.

8. Privacy:

The event organiser will collect and process participants' personal data in accordance with applicable data protection laws. By participating in the event, participants agree to the event organiser's privacy policy.

To ensure your protection of privacy, all data is saved electronically. The athlete acknowledges and agrees that all their personal data may be used and processed by the organiser and its sponsors and third party service providers for business purposes, including for marketing, service development and improvement, analytics, industry and market research, and such other purposes consistent with the organiser's legitimate business needs. Pursuant to such consent to the use of the personal data, the organiser, its sponsors and third-party service providers and their agents are not liable for the way the personal data will be used. For purposes hereof, "personal data" means data relating to identifiable natural persons.

9. Photography and Filming:

Participants are allowed to take personal photographs or videos during the event for personal use only.

Commercial photography or filming is strictly prohibited unless prior permission is obtained from the event organiser.

Participants may be photographed or filmed by the event organiser or authorised third parties for promotional purposes.

10. Governing Law:

These terms and conditions shall be governed by and construed in accordance with the laws of the United Arab Emirates.

Any dispute arising out of or in connection with these terms and conditions shall be subject to the exclusive jurisdiction of the courts of Abu Dhabi.

By participating in the TRICATIONS the athlete acknowledges that they have read, understood, and agreed to these terms and conditions. Failure to comply with any of the terms and conditions may result in exclusion from the event/trip.
